#### KEY ACTION POINTS

1. DTS + MM: to send to APSS ČR electronic version of answers to key questions from focus group; **deadline: 31/7/2019**
2. DTS: to resend electronic form of questionnaire survey to A.D.I.V. Romanian (EAN member); **deadline: 31/7/2019** – done; they filled questionnaire
3. EF: to send to APSS ČR scans of filled questionnaire surveys; **deadline: 31/7/2019**
4. JPF: to send to APSS ČR confirmation about relationship to Lebenswelt Heim – see e-mail from 24/6/2019; **deadline: 31/7/2019**
5. MM + DTS: to send to APSS ČR minutes from national focus group; **deadline: 31/7/2019**
6. MM + DTS + PJ: to prepare in cooperation general conclusion from 3 documents from focus group in every country; this document called „**The new EAN certificate puzzles**“ (working title) should contain draft version of topics and graduate profile; **deadline: 31/8/2019**
7. DTS: to set the terms of focus groups in Romania – 2nd focus group at the latest 11/2019; 3rd focus group between 2/2020 and 4/2020; **deadline: 30/9/2019**
8. On 2nd and 3rd national focus group should be discussed document „**The new EAN certificate puzzles**“ (working title)
9. Tasks for next national focus groups in every country:



- Austrian focus group should well consider and discuss the situation if manager has current E.D.E certificate and will wants to get a new one EAN certificate; there is no problem with this fact in Czech Republic and in Romania – nobody has in this countries E.D.E certificate
- To clarify and define the roles of our organisations in the whole new EAN system of education
- To clarify the situation if applicant about the EAN certificate has a long experience in social services and hasn't university education – is it possible or will we insist on a university degree?
- To set a draft version about regularly updating of the new curriculum:
  - Will we in the same group regularly to meet? E.g. every 3 years?
  - Would it be sufficient if the meeting will be only for Austrian colleagues? – The have experience with current education
  - There is possibility to arrange some meeting about update on EAN platform – because there is good possibility to join other participants from other countries (e.g. France, Slovenia) and to get feedback
